In the fiscal year ending June 30, 2024, MyPath served more than 3,400 young people across the US, helping them embark on a path to long-term financial stability through foundational financial education, connections to youth-friendly financial products, personal financial mentoring, youth leadership training, guaranteed income programming, and student loan debt counseling. On average, MyPath youth saved 30% of their income; 75% reported increased financial knowledge and confidence in the areas of saving and credit; 100% of mentees set a financial goal, and 100% of mentees set aside emergency savings. MyPath youth leaders and staff also illuminated the barriers to youth financial inclusion and outlined the resources needed to advance MyPath's Youth Economic Bill of Rights through field and awareness building.
